





Avis Bank Ltd has been assigned the following Issuer Identification Number (IIN) and will be identified in the ISO/IEC 7812 database as follows: 56444500

This assignment is a very important institutional record. This e-mail and signed application (see attached) should be provided to Avis Bank Lt so that they may keep it with their permanent records.

It is important that the information contained in the ISO/IEC 7812 database remain accurate. Avis Bank Ltd must notify the ISO/IEC 7812 Registration Authority (RA) if any of the information is not listed correctly. They must also notify the RA of any changes as they occur so that the RA can ensure that all information in the database is kept current. The American Bankers Association (ABA), in its role as the ISO/IEC 7812 Registration Authority, does not take responsibility for incorrect information listed on the Register.

Effective January 2017 - ISO/IEC 7812-1 was revised to extend the length of the IIN from a fixed-length numeric of 6-digits to an 8-digit numeric value. This revision to the standard was formally published in January 2017. Any new applications submitted to the RA are fulfilled as 8 digit IINs.

Please note Avis Bank Ltd has been assigned an 8-digit (IN. It is important to note that if you Intend to Implement your card program using the first 6 digits, you are prohibited from using any numbers in the 7th and 8th position starting with 01 through 99. You may find the attached information sheet – "How To Use Your IIN" helpful.
